3 Panel Feedback

- 3.1 The Panel invites the Police and Crime Commissioner to consider the following points when finalising his Annual Report 2022 2023:
- 3.2 **Tackling Drugs** Your Police and Crime Plan includes several objectives that focus on tackling drug related crime and reducing the harm caused by drugs, and we note the statement in your Annual Report that it is estimated that half of all homicides and acquisitive crimes are drug related. However, we believe your Annual Report should include more information for the public about the range of drug intervention activities you oversee, together with details of progress to demonstrate the impact of this work.
- 3.3 **Road Safety** We suggest the Annual Report includes more detail of activities you have undertaken towards meeting your road safety objectives, together with information demonstrating the impact of this work.
- 3.4 **Performance Data** We note that a link to the performance dashboard is included in the Annual Report and welcome this additional data on how your Police and Crime Plan objectives are being met. However, we suggest the way data is presented in the Annual Report is reviewed, with a view to streamlining the text and providing at-a-glance

information. We believe this will improve clarity to the public on progress and the trajectory of performance and trends.

3.5 **Foreword** – We would suggest that you consider removing references to political issues made in the Annual Report foreword and wider body text so that it has greater focus on the delivery of your Police and Crime Plan.
